### MOTION TO REINSTATE PETITION FOR REVIEW

The Defendant-Appellant-Petition, James Fetzer, moves the Supreme Court to vacate its Order of May 18, 2021, attached hereto, dismissing Petitioner's Petition for Review, and to further reinstate the Petition. The Court's Order is based on a miscalculation as to the date of the Court of Appeals' Decision from which Petitioner seeks review.

The Supreme Court calculated the time for petitioning from an erroneous date. The Court considered the date of the Court of Appeals' Decision to be April 6, 2021. In fact, the Court of Appeals denied Petitioner's Motion for Reconsideration on April 7, 2021. A true and correct copy of the Court of Appeals Decision, showing a filing date of April 7, 2021, is attached to this Motion for the Court's convenience.

Wis. Stat. § 808.10(1) requires that a petition for review be filed in the Supreme Court within 30 days of the date of decision by the Court of Appeals. Section 808.10(2), however, tolls the 30-day time period to file the petition for review in the event that a motion for reconsideration is filed, as in this case. In such case, the 30-day time period

starts on the date that the Court of Appeals determines the motion for reconsideration by filing an order denying the motion for reconsideration or an amended decision.

The Petitioner timely filed his Petition for Review within 30 days after the Court of Appeals denied his Motion for Reconsideration. The Petition for Review was filed on May 7, 2021 within 30 days after the Court of Appeals denied the Motion for Reconsideration. (See attached.)

The Petitioner, accordingly, moves the Supreme Court to vacate its Order dismissing the Petition for Review. The Petitioner further requests the Court to reinstate his Petition by recognizing timely filing on May 7, 2021, within 30 days of Court of Appeals' decision of April 7, 2021. The Court based its Order of dismissal on a miscalculation of the date of the Court of Appeals decision triggering the 30-day period for filing the Petition for Review.
